Add to Clause 3 Objects material in red below [note from Secretary – the English is not perfect but the requirement comes from the Office of the Scottish Charity Regulator so I propose that we follow it to the letter]

Objects

- 1) To alleviate physical or mental distress of any persons affected in any way by the Relevant Conditions and Treatments
- 2) To provide education to those affected, and to the general public, about the Relevant Conditions and Treatments
- 3) To promote, encourage, collaborate with, and providing funding for research projects associated with Relevant Conditions and Treatments

Appendix 2

In furtherance of the above objects, but not otherwise, the OPA may:

- 14) None of the organisation's assets may be distributed or otherwise applied (on being wound up or at any other time) except to further its charitable purposes.
- 15) Nothing in this constitution shall authorise an application of the property of the charity for purposes which are not charitable in accordance with section 7 of the Charities and Trustee Investment (Scotland) Act 2005."

Amend Clause 5 Management as follows [Note from Secretary – this is an administrative clarification]

(a) The OPA shall be managed by a General Committee (hereinafter called the Committee) consisting of a Chair, Treasurer and Secretary and not more than 8 other members elected at the Annual General Meeting of the OPA in accordance with clause 5 hereof. The members of the Committee shall act as Trustees. The Committee shall meet at least twice each year and the Secretary shall circulate an agenda at least seven days before each meeting. Urgent items may be added to the agenda if the Committee so agrees.

Amend Clause 6 [Note from Secretary – this is an administrative clarification]

- 6 Election of Honorary Officers and Committee Members
- (a) At the Annual General Meeting hereinafter mentioned the OPA shall elect a Chair, Secretary, Treasurer and other such Committee members as the OPA shall from time to time decide. The Secretary shall organise the AGM, giving members at least twenty-one days' notice. Notice may be given in writing or electronically

Amend Clause 7 [Note from Secretary – this is an administrative clarification]

(a) A bank account shall be opened in the name of the OPA with the HSBC Bank, Solihull, or with such other Bank as the Committee shall from time to time decide. The Committee shall authorise in writing the Treasurer, one other member of the Committee and the Chair of the Committee to sign cheques on behalf of the OPA and may authorise the Treasurer to make payments electronically, in which case adequate written controls shall be put in place by the Committee. All cheques must be signed by not less than two of the three authorised signatories

OPA Chairman's Summary 2016

Last year has been another successful one for the association. We have recruited new trustees- Philip Wright, Philip Coverdale, Hilary Ryan and Grant Fullerton together with recruiting Katie Pollock to direct fund raising. They will I am sure help and support those of us who remain including Ed Cheong, Barry Moorfield, Damien Cassidy and our hardworking secretary Haward Soper. We sadly say goodbye to two long standing trustees, Anthony Ingold and John Taylor and our advisor Jane Darnton. The office staffed by Maggie supported by Drew remains the centre of OPA activities.

We have continued to expand our own support groups whilst developing close links to other local groups – affiliates, to widen the coverage of support available to patients. We work closely with MacMillan and Maggie's Centre's to provide comprehensive support. We are very pleased with the developments in Scotland and Wales. We now have 54 groups in total – 11 OPA, 8 Scotland and 36 Affiliates. London has now been resolved with overall control moving to OPA offices with an annual meeting for all at Guys and local groups continuing. A total of 220 meeting took place in 2016 with 20 visits from trustees.

All our documentation, pamphlets and restaurant cards are available free to all who request them. The OPA distributed over 10,000 booklets, "A guide to Life after Surgery", "Swallowing & Nutrition" and "All about the OPA" in 2016. We are currently producing a new booklet – a guide to patients through the journey from diagnosis to completion of treatment and follow up in conjunction with the St Thomas Team in London. This will be available in 2017 as will a carer focussed booklet being produced by Philip Wright.

The web site is heavily used and appreciated with visitors to the OPA website of 13,047 and Social media over 1,000 followers.

We now have a membership of 6429 patients and carers. The office deals with 1000+ calls and emails per month with back up to the staff from experienced and trained past patients and the clinical trustees. We never give clinical advice or comment on treatment. We encourage all patients who approach us to explain their anxieties to the team caring for them and if necessary to request a second opinion.

Total Mass communications sent out to patients & Health Care Professionals was over 20,000.

The OPA raised funds of approximately £105,000 in 2016 to fund its activities and run the central office.

This constituted £71,247 from individual one off donations, £32,000 from trusts and other organisations and £2450 from other sources.

We also are committed to raising awareness and in 2017 will be producing new posters, a leaflet and pamphlet all using our Ref-Lux logo. These will be available for awareness days – our members undertook 10 in 2016 – as soon as they are produced. We are also members of groups such as Action against Heartburn and the Westminster campaign.

Although we do not actively undertake research we encourage all our members to be involved in local research projects run by their centres and contribute to national trials and research including NICE by providing patient representatives when requested.


PARKING PERMIT
